1.	<p>Would this funding be similar to CESH? Is this something we can utilize to fund motel vouchers, rental assistance, etc...</p>	<p>Emergency Shelter, as a standalone activity, is not aligned with the funding priorities determined by Imperial Valley Continuum of Care Council (IVCCC).</p> <p>On June 9, 2022, the IVCCC Executive Board approved a specific list of eligible activities based on local need. These activities were ranked from highest to lowest priority:</p> <ul style="list-style-type: none"> • Delivery of Permanent housing and innovative solutions • Rapid Re-housing • Services Coordination • Street Outreach <p>An applicant may consider including HHAP 3 non-congregate emergency shelter, (hotel/motel vouchers) as part of a Rapid Re-housing (RRH) program to bridge the participant from literal homelessness to permanent housing. Proposed RRH programs are not eligible if non-congregate emergency shelter is provided without RRH services. Non-congregate emergency shelter may only be used as part of an overall RRH program to include case management, RRH rental subsidies, incentives to landlords and/ or security deposits to bridge the participant to permanent housing.</p>
2.	<p>Is your office the central hub for permanent supportive funding in Imperial County?</p>	<p>Imperial Valley Continuum of Care Council (IVCCC) with the assistance of the Administrative Entity for the IVCCC, Imperial County Department of Social Services, is not the only agency that offers opportunities to apply for permanent supportive</p>

IVCCC makes funding decisions and/or recommendations on grants administered by the Continuum of Care (CoC).</p> <p>Request for proposals (RFP) notifications, of grants specifically administered by CoC, are posted on the IVCCC website (https://www.imperialvalleycontinuumofcare.org/) and the Imperial County Purchasing Department website (https://purchasing.imperialcounty.org/rfqs-rfps/).</p> <p>RFPs released by other county departments may be found on the Imperial County Purchasing Department website.</p> <p>With HHAP 3 funding, permanent housing solutions may include, but are not limited to:</p> <ul style="list-style-type: none"> • Capital and improvement costs, including new construction, expansion, renovation, or replacement of infrastructure, for permanent supportive housing. • Hotel and motel conversions to permanent housing. • Fifth wheel trailer with a lease agreement and utilities hook-ups. • Purchase of a tiny home with in-unit kitchen and bath which would be located in a mobile home or special occupancy park with hookups. • Rezoning costs necessary to build permanent housing. <p>Permanent housing solutions funded by HHAP dollars must be used for eligible populations and meet habitability standards.</p>
