This Addendum is hereby made part of the contract documents and specifications to the same extent as if originally included therein and shall be signed by the Grant Analyst.

**Revision No. 1:** HHAP 5 Request for Proposals, page 10, Section 11: Evaluation and Selection Process, originally stated:

A non-conflicted Scoring and Ranking Committee, meticulously selected by the IVCCC, will review, score, and rank each proposal that has met the minimum threshold criteria. The intent is to select proposals in accordance with the evaluation criteria outlined in this RFP. For proposals with more than one eligible activity, bonus points will be applied only to the eligible activity that encompasses the highest proportion of the budget. The highest possible score is 110 points.

HHAP 5 Request for Proposals, page 10, Section 11: Evaluation and Selection Process, has been modified to read as follows:

A non-conflicted Scoring and Ranking Committee, meticulously selected by the IVCCC, will review, score, and rank each proposal that has met the minimum threshold criteria. The intent is to select proposals in accordance with the evaluation criteria outlined in this RFP. For proposals with more than one eligible activity, bonus points will be applied only to the eligible activity that encompasses the highest proportion of the budget. The highest possible score is 115.

**Revision No. 2:** HHAP 5 Request for Proposals, page 12, Bonus Points table originally stated:
